

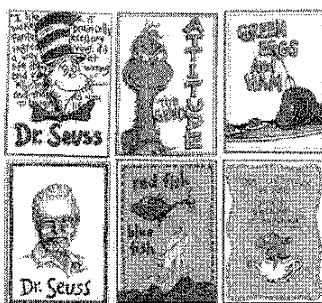

Please note that this year each child may exhibit up to 3 art exhibits and 8 photographs.

Please bring **all other exhibits except animals on Thursday, September 29th between noon and 5:30 p.m.** to the High School. The gym closes at 5:30 p.m. for judging, so that the judges and assistants can also enjoy the homecoming celebrations that evening.
