Some language from the new policy was added into policy 852 (at the 2 nd reading) that explains what distribution of literature means, and also more information on the kind of literature that is prohibited (e.g. incites violence or is vulgar/profane or promotes illegal activities).

If the school board would like to put a limit on class sizes, this is the policy where that would take place.
