3: 2023-2024 Budget Update			Krey said that the current projection of the CPI for 2023-2024 base wages is approximately 8.00%. The current budget and financial forecast have an increase of 4.00%. As discussed last month, a 0.5% increase in base wages equals approximately \$50,000. In addition, he noted that the District has a rate cap of 7.0% for the upcoming health plan year, which begins on 9/1/2023. Discussion on the amount of employer-sponsored HSA amounts if the health insurance renewal returns at 7.0%. Discussion on CPI and base wage increases for staff. Discussion on market based increases for staff.

4: 2023-2028 Transportation Contract Details		Krey stated that he had a meeting with Lamers last week to discuss contract details with Lamers. Krey stated he made a request that the increases in years 2 through 5 of the new contract not be related to the consumer price index. Rather, the District wants hard numbers and would be open to a range. Lamers requested that they be compensated a minimum number of days if the district were to close school for weather, pandemic, or other reasons. Lamers request was to receive a bus rate per day, which is approximately \$227 per route per day in each year of the upcoming contract. This request does not include the additional mileage charged during a regular transportation day. Lamers proposed a minimum rate increase of 2.5% and maximum of 5.0% in years 2 and 3 (2024-2025 & 2025-2026). In addition, years 4 and 5 would be negotiated prior to those years. Discussion on counter offer to Lamers. Krey will return in February with updated information on this topic. No action was taken.

Currently, the District is short 6 hours. Administration is proposing that half days with students (and half day in-service for staff) on February 17 and March 24 be converted to full days. In addition, April 10 (currently an in-service day/workshop day for staff) be changed to a full school day. By converting these days, we would have just over one day in our 'bank' for potential/future closings for the rest of the year. 2023-2024 (Next Year): A few minor changes based on feedback from staff on the calendar presented at the December 2022 board meeting. *Motion to approve February 17, March 24, and April 10 as full student contact days for the 2022-2023 school year.
