Masking quarantining is required for household contacts. If there is a confirmed positive Covid case in the home, all members exposed will be masked quarantined at school home for ten days usering any symptoms with testing recommended on day 5 or 6 on day 3-5.
Instructional Model for the 2021-22 School Year	Fred	Sara	Recommend to the Board to make the following change: Page 6 of the Instructional Model: delete item#3 (follow building thresholds for all buildings, and not grades; mask for 5 days based on Page 7) Additionally, in Grades PreK through Grade 6, masking will be enforced for ten days for a particular grade when there is one confirmed positive Covid case for that particular grade. It was decided that the grade (due to intermingling) was the designated cohort.
