2. Update on FEMA BRIC Grant

Administration will provide an update on a revised process and timeline.

3. 2024-2025 Budget Update

No updates at this time.

4. 2025-2026 Budget Update

First, the Department of Education has called for significant changes in the federal agency's service goals. The amount of federal revenue River Valley is projecting for the 2025-2026 school year includes:

- Fund 10, General Fund: \$212,033. Includes Title 1 (reading instruction), Title 2 (class size reduction), and Title 4 (learning outcomes) grants.
- Fund 27, Special Education: \$492,454. Includes Flow Through and Early Childhood grants.
- Fund 50, Food Service, \$368,976. Includes aid for national school breakfast and lunch programs.

Next, the Wisconsin Employment Relations Commission (WERC) has published the CPI to be used as a maximum amount for base wages in 2025-2026, which is 2.95%. This percentage and historical percentages are online here: https://werc.wi.gov/doaroot/cpi-u chart.htm

Last, the District has received initial renewals from Quartz (Health Insurance) and Delta Dental (Dental & Vision Insurance) for the 2025-2026 school year.

The health insurance renewal returned at 16.9%, while Dental is 4%, and Vision at 3%.

5. Preliminary Discussion of 2025-2026 Wages

Administration is seeking to have a preliminary discussion on the wage increases for 2025-2026, and plan to wait until after the referendum to make final decisions.

6. 2024-2025 and 2025-2026 Projects

Administration is seeking a discussion on maintenance projects for the summer of 2025 and summer of 2026.

7. Audit Renewal Fiscal Years 2026-2028

The District's agreement with HawkinsAsh to complete the annual audit expires after the current school year. I asked HawkinsAsh for a three year extension proposal that would cover the 2026 through 2028 fiscal years. HawkinsAsh proposed prices of:

FY2026: \$23,000. FY2027: \$24,000. FY2028: \$25,000.

The current fiscal year (2024-2025) charge from HawkinsAsh is \$15,000.
