2: Stadium Upgrade Project			Krey stated that fundraising efforts have raised \$685,862 (of the \$750,000) as of 8:00 am this morning (3/21/2022). With the referendum campaign in full swing, we have not promoted this project since December, but plan to begin posting on social media after the referendum on April 5 to reach the total goal. Meise Construction plans to start the project on April 1. Krey stated that the soccer, football, and track coaches have had conversations about the field design and layout since the beginning of January. While working with Rettler, the group has gone back and forth on design. The current concept "Concept #6" is the design that everyone involved is very happy with. The group wanted to ensure that the design appeared as a dual-purpose field. Discussion on ensuring the stadium project would serve as a dual-purpose field for football and soccer. The committee agreed to move forward with the design that the coaches came up with (concept #6). The committee asked Krey to investigate the current ticket booth and entrance to the stadium.
