Selection of Instructional Materials

The Board of Education shall provide instructional materials and equipment, to provide adequate instructional materials, texts, and library services, which reflect the cultural diversity and pluralistic nature of American society.

Although the Board is legally responsible for the operation of the school and recognizes the students' right to free access to many different types of information, the responsibility for the selection of instructional materials is delegated to the appropriate staff and administration.

The River Valley School District does not discriminate on the basis of gender, race, national origin, sex, age, ancestry, religion, creed, color, class, pregnancy, marital or parental status, sexual orientation, disability or other protected status in the selection and evaluation of instructional and library materials or media or in its programs and activities and provides equal access to the Boy Scouts and other designated youth groups. Discrimination complaints shall be processed in accordance with established procedures.

Complaints alleging sexual harassment occurring before August 1, 2024, are governed by policies 411.3 and 511.2. Complaints alleging discrimination on the basis of sex (including sex-based harassment) occurring after August 1, 2024, are governed by policy 411.5/511.3.

The Board shall review this policy and its implementing procedures periodically.
