President Jennings opened the meeting. She noted that the meeting had been properly posted and notice had been provided to the appropriate media and each School Board Member. Iausly moved to proceed with the legal meeting. Young seconded. Motion carried.

Student Council Report

Glasbrenner shared a report prepared by the Board's student council representatives. All elementary students attended the Opera for the Young's production of *Cinderella* and all will participate in their first annual spring concert since 2019, to be held on May 9 at the high school.

High school music seniors traveled to Chicago to see the musical *Moulin Rouge*. More than 40 high school events will be headed to the State Solo and Ensemble at UW-Platteville on April 30 and the final band and choir concert this year is on May 25. The high school library remodel is complete except the outdoor space. Students in Business Concepts class are working on entrepreneurial skills and each pitched a new product. Jacob Klein, Bodhi Kauss, and Jordan Jensen made it to the final round and will compete on the Madison College campus on May 6. The fitness trail will be finalized by the end of the school year and a 9 hole disc golf course will also be installed on the school campus by August 1. Students Ryan Norton and Jackson Thier are involved in these two projects and thanked the Endowment Committee for grants for funding. Jennings thanked the Slowpoke for sponsoring a fundraiser which showcased State Solo and Ensemble participants and raised funds for Ukraine.

<u>Update on School District Operations from Administration</u>

Glasbrenner noted that a flyer was mailed out by the Dodgeville School District, which highlighted their district and open enrollment, and was received by some River Valley residents. Dodgeville apologized to Glasbrenner and said the flyer was only meant to be sent to students in their district and was sent in error to some River Valley residents.

Peterson noted that end of the year field trips are being planned and staff and students are excited for one more step toward normalcy. The PTO provides a lot of funding for elementary student events, with the Blackhawk Bolt being the biggest fundraiser. Students are currently involved in state testing.

Radtke noted state testing will take place next week. End of year celebrations and field trips are being planned.

Blakley noted they have finished ACT Aspire testing and prom is next Saturday. Registration day for next year was held last week. Students are excited about happenings this time of year.
