## SCHOOL ADMISSIONS

Any student seeking entrance into the River Valley School District must reside within the established boundaries of the district, except as otherwise allowed by state law.

Students admitted to the district's elementary and secondary schools shall present immunization records as required by law.

The River Valley School District, in accordance with state law, is not required to enroll a student during the term of his/her expulsion from another school district.

The River Valley School District does not discriminate on the basis of gender, race, color, national origin, sex, age, ancestry, creed, religion, pregnancy, marital or parental status, sexual orientation, gender identity, or disability in admissions to any school, class, program or activity; in a facilities usage; or in its programs and activities and provides equal access to the Boy Scouts and other designated youth groups. Discrimination complaints shall be processed in accordance with established procedures.
