## **Student Discipline**

The behavior of students attending River Valley Schools shall reflect standards of good citizenship, self-discipline, responsibility for one's own actions and respect toward others. Rules of behavior and discipline extend from the classroom to all school property, school buses, and school sponsored events whether or not on school property.

Positive discipline is a necessary element and provides all students with a healthy learning environment. All students will be assisted in every way possible to achieve scholastic success.

A basic disciplinary code of conduct shall be established in Board policy. Under this policy the elementary schools, middle school, and high school shall all establish their own methods and procedures for a disciplinary process. These rules and procedures shall be made available on an annual basis.

Current disciplinary procedures utilize PBIS (Positive Behavior Interventions and Supports) and SOLAR (Solution Oriented Learning, Accountability, and Restoration)
