STUDENT SCHOLARSHIPS

Students in the River Valley School District shall be informed annually of any available scholarships.

Available scholarships are posted on the River Valley High School Counseling Department Web site. High school counselors may also notify students of scholarship opportunities via school-wide announcements and classroom presentations.

Criteria for school district scholarships shall be developed consistent with school district goals and objectives.

The River Valley School District shall not discriminate in the acceptance and administration of gifts, bequests, scholarships and other aids, benefits or services to students from private agencies, organizations or persons. Discrimination complaints shall be processed in accordance with established procedures.

The River Valley School District does not discriminate on the basis of gender, race, color, national origin, ancestry, religion, sex, age, creed, pregnancy, marital or parental status, sexual orientation or disability in its programs and activities and provides equal access to the Boy Scouts and other designated youth groups. The following people have been designated to handle inquiries regarding non-discrimination policies: Business Manager, 660 W. Any student, parent, or resident of the district complaining of discrimination against a student as described in Policy #411 shall report the complaint in writing to the principal.

Complaints alleging sexual harassment occurring before August 1, 2024, are governed by policies 411.3 and 511.2. Complaints alleging discrimination on the basis of sex (including sex-based harassment) occurring after August 1, 2024, are governed by policy 411.5/511.3.
