#### Student Council Report

Eva Iausly was present. The student council recognized staff during teacher appreciation week. The student council will work shifts at the Little Hawks Track and Field event to help cover the cost of the appreciation gifts and the student council scholarship. The Middle School Shakespeare Group will perform The Merry Wives of Windsor at the end of May. At the high school, 8 students went to state forensics competition and several students attended state solo and ensemble. Also, 5 music students earned spots in the state honors mixed choir, 1 student earned a spot in the state honors treble choir, and 1 student earned a spot in the state honors orchestra. There is a band and choir concert on May 15. Heidi Radel, Business Teacher, was awarded a gold star teacher award and her personal finance students were recognized for excellence with 93% passing a financial literacy certification test. Radel also took 80 business students to a "Get Real" life simulation event where students paid taxes, housing, child care, gas, investments, etc. and were randomly assigned marital status, credit card debt, tickets from law enforcement, health emergencies, etc.
