These are the changes from the 1 st reading: State statutes have been amended to change the procedures that apply to calling and providing school board members with notice of special school board meetings. The clerk is still required to provide notice of the special meeting to each member of the school board, but it is now permitted to issue the notice "in a manner likely to give the school board member notice of the meeting. Prior law had expressly required that the notice had to be "in writing" and that it had to be delivered to board members using one of several specific methods. Email is now considered an acceptable method of notification.

Brian Krey reviewed and updated the entire policy, including the name change. Change the word "Board" to "District" throughout policy Change parents to parents/guardians throughout policy Under the section "Service Animals for Students" add a language that if the student is unable to control their service animal and requires another person as a handler, the District is not required to provide the handler. Under the section "Eligibility of a Student's Service Animal for Transportation—situations that would cause cessation of transportation privileges for the service animal" change the language from "The service animal urinates or defecates on the bus" to "The service animal demonstrates it is not housebroken." This will match language in a previous section of this policy. Under the section "Vaccination, Licensing and/or Veterinary Requirements" add language that the service animal needs to also meet Local regulations (in addition to State & County regulations), and remove specific language regarding rabies vaccinations.
