The handbook spells out the process of how conflicts are to be handled, and the Administrator's contract states the duties of the job take priority over coaching duties. Head coach duties may take more time than an Administrator can give to that position, but varsity reserve or freshman coaching would take less time, and this was not seen as a problem by the Policy Committee. It was decided there doesn't need to be any updates to the policy or handbook, or reference to admin contracts—no further action needed.

At the 2nd reading, these changes were made: In the "Physical Activity" section: removed "or physical education" to state that withholding physical activity as discipline could include withholding recess or physical activity breaks, but not physical education. In the "Physical Activity" section: Removed hyperlink directing to activity break ideas in the policy because these change so often—instead, directed reader to the DPI webpage for Physical Education & Physical Activities. In the "Nutrition Promotion" section: current policy states items in the snack vending machines are to be reviewed by the Healthy Kids Initiative Committee (Wellness Committee) every year—changed this to say that only new items being offered in the vending machines need to be reviewed. Also the nutritional information for products in the vending machines should be available to the School Board at the beginning of each school year (removed language stating this information would be <i>presented</i> to the School Board each year). At the 1st reading, these changes were made: Added language on advice of the attorney regarding students placed in off-site separate education settings. Updated first paragraph to remove philosophic goals of the District. Removed specific requirements of physical education for all grades, and make it more general by stating the district will meet DPI physical education requirements. Add cross references 345.54: .5 Credit Physical Education Exemption and DPI Chapter 8 School District Standards.
