FOOD SERVICE MANAGEMENT

The objective of the school lunch program will be to safeguard and improve the health and well-being of school students. The lunchroom should be considered an educational facility for teaching good dietary practices through the serving of nutritionally adequate and attractive meals.

The River Valley School District shall provide hot lunches through participation in the National School Lunch Program. The district administrator, or his/her designee, shall enter into an agreement with the Department of Public Instruction and the federal government for participation in such child nutrition program.

As required for participation in the National School Lunch Program, the school district agrees to the following:

That a school lunch meeting federal regulations be made available for all students.

That free and reduced price lunches be offered to eligible students who apply and who meet the federal income guidelines.

The supervisor of food services shall be responsible for the management of the school lunch program, including the purchase of food and supplies, under the direction of the Business Manager.

Food service and milk prices shall be established annually by the Board. Any meals and milk sold by the school may be purchased by students, staff and community residents in accordance with the prices set forth by the Board.

In accordance with Federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, the USDA, its Agencies, offices, and employees, and institutions participating in or administering USDA programs are prohibited from discriminating based on race, color, national origin, sex, religious creed, disability, age, political beliefs, or reprisal or retaliation for prior civil rights activity in any program or activity conducted or funded by USDA.

Persons with disabilities who require alternative means of communication for program information (e.g. Braille, large print, audiotape, American Sign Language, etc.), should contact the Agency (State or local) where they applied for benefits. Individuals who are deaf, hard of hearing or have speech disabilities may contact USDA through the Federal Relay Service at (800) 877-8339. Additionally, program information may be made available in languages other than English.

The River Valley School District does not discriminate on the basis of race, color, national origin, sex, disability, ancestry, creed, pregnancy, marital or parental status, sexual orientation, or age in school-sponsored food service programs or in its programs and activities and provides equal access to the Boy Scouts and other designated youth groups.
