The revised language is from 1964, and the Office of Civil Rights required this change. The revised language is:</p> <p>The River Valley School District does not discriminate on the basis of gender, race, national origin, sex, age, ancestry, religion, creed, color, class, pregnancy, marital or parental status, sexual orientation disability or other protected status in the selection and evaluation of instructional and library materials or media or in its programs and activities and provides equal access to the Boy Scouts and other designated youth groups.
