728 Mask Policy	Deb	Fred	 Policy will be on the agenda every month to address concerns or changes necessary. Dr. Furukawa put forth the idea of having an oversight group or compliance review group that would tour the campus each month to see how the social distancing, mask/face coverings, handwashing and outdoor use practices are going. The group could include a Board member, school nurse, Dr. Furukawa, principal and/or District Administrator. The consensus of the committee is this is a good idea. Loren Glassbrenner will put together a schedule to start doing a monthly walk thru with this group. Recommend to bring this language to the Board for a 2nd reading (skip the1st reading). Revised language to more closely match the Governor's order, and not allow students, employees, visitors and volunteers to un-mask when they feel they are socially distanced. The intent of RV's policy is to be masked when indoors, and the policy points out exceptions (e.g. eating/drinking).
411.1 Bullying/Harassment	Fred	Kathy	Recommend to bring this language to the Board for a 2 nd reading (skip the1st reading). The District's lawyer helped insert language into the policy to address "hate speech, which includes the use of language, behavior or images/symbols that express prejudice.

431 Student Attendance	Kathy	Fred	Recommend to bring this language to the Board for a 1st reading. Removed 1 st paragraph, but did not change what the policy covers. The committee reviewed this policy to see if language would need to be updated to cover situations/education during Covid19. Loren Glassbrenner informed the committee that the waivers to the DPI will cover the different scenarios due to Covid19, and we do not need to adjust out regular policies.
