
- Annual Grant Program Through Federal Emergency Management Agency (FEMA)
- Objectives
 - Reduce Risk To Individuals & Property From Natural Disasters
 - Reduce Reliance On Federal Funding From Future Disasters
- Mitigation Planning
 - Break Cycle
 - Damage
 - Reconstruction
 - Repeated Damage
- Highly Competitive National Grant Program
 - \$500 Million FY 2020
 - \$1 Billion FY 2021
 - o \$2 Billion FY 2022
 - \$1 Billion FY2023
 - o TBD FY2024





Application Process

- Open Application Cycle
 - Beginning of October Third Week of January
- Wisconsin Emergency Management
 - o Notice of Intent November, 2024
 - Final Draft January, 2025
- Grant Selection & Award Timeline
 - o Application Deadline January, 2025
 - Selection Announcement Summer, 2025
 - Anticipated Award Date December, 2025*
 - Expect May 2026
- Period of Performance
 - o 36 Months
 - Cannot Start Until Grant Is Awarded





Grant Program Requirements

- Benefit Cost Analysis
 - Benefit-Cost Ratio (BCR)
 - Greater Than 1.0
- Cost Share or Match
 - Standard Cost Share
 - 75% Federal Funding of Eligible Costs
 - 25% Local Funding of Eligible Costs
 - Economically-Disadvantaged Cost Share*
 - 90% Federal Funding of Eligible Costs
 - 10% Local Funding of Eligible Costs
 - Maximum Federal Share
 - \$50 Million for Mitigation Projects





Grant Program Eligibility

- State, Territorial, Tribal or Local Governments
 - Public School District
 - Local Municipality
- Hazard Mitigation Plan
 - Consistent With Plan Goals & Objectives
- System for Award Management (SAM)
- FEMA Wind Zone Region
- Floodplain
 - Cannot Be Located Within Floodplain





Grant Program Flexibility

- River Valley School District or Village of Spring Green
 - Pass Resolution
 - Giving Admin and/or Board Member Signature Authority
- No Fiscal Responsibility Until Work Would Begin
 - River Valley School District or Village of Spring Green
 - Cost Share Agreement
 - Maintenance Agreement
 - Operations & Management Agreement
- Tremendously Flexible Program
 - Funds Can Be Declined At Any Time
 - No Penalties or Repercussions

- Determine Level of Interest
 - Explore Facility Goals & Needs
 - Determine Ideal Timeline
