

## **RESOLUTION AUTHORIZING CONTRACT RENEWALS**

WHEREAS, the River Valley School District (sometimes hereinafter referred to herein as the “District”) has a collective bargaining agreement with the River Valley Education Association (sometimes hereinafter referred to herein as the “Association”) covering teachers as defined in said collective bargaining agreement;

WHEREAS, the District is obligated under Section 118.22(2) of the Wisconsin Statutes to give a written notice of renewal or refusal to renew their individual contracts for the ensuing year on or before May 15 of this year;

WHEREAS, this Board has reviewed the contracts of the teachers included in the bargaining unit of the Association and has heard the recommendations of the Administration as to the continuation of each of the positions involved;

WHEREAS, a schedule has been prepared, Schedule A attached hereto, setting forth the names of the teachers affected by this resolution;

WHEREAS, the administration has caused forms to be prepared to be used in connection with this resolution which have been reviewed by this Board.

NOW, THEREFORE, BE IT RESOLVED BY THE SCHOOL BOARD OF THE RIVER VALLEY SCHOOL DISTRICT AS FOLLOWS:

1. This Board hereby determines that each of the teachers whose names appear on the attached Schedule A shall each have their teaching contracts with this District now in force renewed for the ensuing year, being the 2022-23 school term.

2. The President and Clerk of the District be and they hereby are authorized and directed not later than May 15, 2022, to make, execute and deliver a contract to each of the teachers listed on the attached Schedule A for the 2022-23 school year.

3. Each of said teachers accepting said offer of contract on or before June 15, 2022, shall be deemed to have a contract for the 2022-23 school year. The offer of this Board and the acceptance of the teacher shall constitute a contract for the ensuing year. Any of said teachers rejecting said offer or failing to accept the offer by June 15, 2022, may be deemed to have terminated his or her present contract as of the end of the 2021-22 school year. Each teacher shall be informed of this requirement.

4. Attached hereto and hereby made a part of this resolution are a letter and contract which are hereby approved by this Board and said District President and District Clerk are authorized and directed to use forms substantially the same as such forms in making and giving said notice of renewal. The Board hereby adopts all of the terms and conditions and each of them included within said documents as being in conformance with the determination of this resolution.

5. Said documents shall be delivered to each teacher personally or sent through district issued email.
